**I. BACKGROUND**

The Global Partnership for Education (GPE), of which Mongolia is a partner, has adopted a new strategic plan for the period 2021-2025, entitled “GPE 2025.” In light of the education challenges that GPE partner countries face, particularly following the pandemic, this plan is an ambitious one and sets out the following goal: “to accelerate progress, learning outcomes and gender equality through equitable, inclusive and resilient education systems fit for the 21st century.” To implement the new plan, the GPE made the Education Sector Plan Implementation Grant (ESPIG) Multiplier Grant, dedicated to supporting the implementation of national Education Sector Plans accessible to certain countries to leverage additional external financing for education.

The Ministry of Education and Science (MES) of Mongolia applied for the GPE Multiplier Grant, intending to complement three projects respectively funded and implemented by the Japan International Cooperation Agency (JICA), Korean International Cooperation Agency (KOICA) and Save the Children (SC). These projects are strengthening school feeding as well as equity and inclusion within the education system in Mongolia. The Multiplier will also enable the MES and partners to address the need to recover from the learning loss caused by the COVID-19 pandemic.

The project has three main components, which are described below:

**Component 1: Inclusive education**

The MES is strongly committed to ensuring that all children, especially children with special needs, have equal access to quality inclusive education. Within this component, it is aimed that access and quality of education for children with special needs are improved by strengthening capacity of primary and secondary education teachers in public schools.

The Inclusive Education component will complement the ongoing teacher professional development program by further integrating inclusive pedagogy in-service teacher training courses and building the capacities of teachers on inclusive education in primary and secondary schools.

The funds from the GPE also will enable effective support to the implementation of related policies and regulations by allowing an increase of the scope of the current projects implemented by Save the Children and JICA and the involvement of more teachers from mainstream schools.

**Component 2: School lunch**

The proposed program would help to implement the Government Action Plan (2020-2024), which aims to increase the budget for student meals and transform primary and secondary schools' "School Snack" program into a "School Lunch Program." The proposed initiative will make a

substantial contribution to enhancing access to education by improving food production and services within schools. It will also result in good improvements in students' eating habits, health, and well-being.

With the potential KOICA project aiming at primary and both lower and upper secondary, MES will be able to achieve its plan to provide students with safe, healthy and nutritious food. Through this project target schools will have a renovated and fully equipped meal service area and a Training Center for Dietitians and Chefs will be established at the Mongolian State University of Science and Technology. Other expected outputs include guidelines for school meal service management, enhanced capacity of school cooks and nutrition staff and improved awareness of stakeholders of the importance of healthy school meals.

### **Component 3: Blended Learning**

The component on 'Blended learning' will support the MES to further mobilize the education partners to jointly design and implement a professional development program for education personnel and in-service teachers. The Teacher Professional Development program will improve teachers' classroom and online teaching methodologies, as well as their confidence in delivering blended learning.

To accelerate the education recovery, the MES wishes to prioritize blended learning, which is a combination of online instructions and self-paced learning with classroom teaching. This component will design a blended learning model, that will be piloted in primary and secondary schools (number to be determined). The integration of the blended learning model in school will enable learners to reconnect to the school environment and engage in a variety of learning opportunities inside and outside the classroom. In case of further school disruption and closure, such a blended learning model could be pivoted to a distance learning program, which will enable learning continuity.

The GPE Multiplier will act as a catalyst, and this component will build on and strengthen the ongoing distance education programs supported by education partners such as UNICEF and the World Bank.

## **II. SCOPE of WORK**

Effectively strategize and oversee procurement activities, encompassing the establishment of Bid Evaluation Committees (BECs), formulation of bid documents, and collaboration with Executing Agencies (EAs), Implementing Agencies (IAs), and technical experts. This includes coordinating the preparation of technical specifications and cost estimates for inclusion in bidding documents, managing the invitation for bids, addressing bidders' inquiries, conducting bid evaluations, and preparing comprehensive bid evaluation minutes and reports. Ensure strict adherence to GPE and Mongolian procurement guidelines, procedures, as well as national laws and regulations, all within the framework of a lump sum contract type.

## **III. DETAILED TASKS**

- Support procurement/administration officer with technical assistance for new Mongolian procurement law provisions.
- Provide on-the-job training for Bid Evaluation Committees (BECs) members during the bidding document preparation and evaluation process.
- Assist in developing bidding documents and evaluating bids for purchasing school cooking equipment, IT equipment, software, and digital devices for students, and laptops for teachers.
- Manage and coordinate all procurement activities by Mongolian procurement guidelines and procedures and national laws and regulations;

- Manage procurement activities including the establishment of bid evaluation committees, preparation of bid documents, an invitation for bids, bidders' inquiries, bid evaluation, preparation of bid evaluation minutes and reports, preparation of contract negotiations with selected bidders;
- Prepare procurement documents such as bidding documents including technical specifications for goods, works, and services to be procured through National Competitive Bidding (NCB), and shopping, bid evaluation minutes and reports, contracts, and other submission documents for Grant Agent (GA)'s review;
- Arrange inspections of goods, works, and services being procured, as well as inspections of their delivery, storage, and distribution to the final destination to ensure timely availability and proper reception, installation, testing, and user training;
- Support to inspect the quality of the procured goods by collecting data and information from the manufacturers, distributors, and suppliers for verification with the specifications before signing acceptance documents for the goods;
- Verify the quality of procured works by gathering data and information from contractors, ensuring alignment with specifications and design drawings;
- Conduct a thorough inspection before notifying the completion of works, facilitating certification by the relevant authorities;
- Collect and maintain complete records of procurement activities under the projects for audits and references by GA and the government.

#### **IV. QUALIFICATIONS and EXPERIENCES**

1. Bachelor's degree in civil engineering, law, economics, business administration or other relevant field; A Master's degree and other advanced degrees are preferred.
2. At least 5 years of project procurement experience with "Law of Mongolia on procurement of goods, works and services with state and local funds"
3. Strong communication skills in Mongolian and English
4. Written and oral English proficiency
5. Excellent time management skills and ability to multi-task and prioritize work
6. Strong organizational and planning skills
7. Possession of an A3 certificate for procurement of goods, works and services to be funded by the state budget
8. Good knowledge of the Procurement law of Mongolia and other Government regulations related to procurement
9. Effective telephone communication and customer service skills
10. Extremely proficient with Microsoft Office software with an understanding of office equipment
11. Have experience working as a procurement manager for a government agency, which will be advantageous.
